**Project Description:**

The **Technical Assistance to the Government of the Republic of Namibia** through the National Planning Commission / National Authorising Authority is a two-year project funded by the European Union (EU). The implementing agency is the Ministry of Industrialisation and Trade while **Dr Michael Humavindu**, the Deputy Executive Director-Industrialisation manages the project. The project has four Result Areas, namely: (i) Improvement of legal and regulatory environment of trade and business; (ii) Enhanced value chain development; (iii) Enhanced information for policy making; and (iv) Improved support structure to business development. The above Result Areas will be achieved through implementing specific activities.
